Using the 2012 Club Tax Printer

This Tax Printer program works with data from ICLUBcentral's Club Accounting software, performing certain calculations, and then generating tax forms with these calculated values. The program does not alter your original club data stored in the Club Accounting software. To properly use this program, you must make sure your accounting records are up-to-date and accurate.

System Requirements

Use of this software requires at least:

- A compatible Windows operating system (Windows 2000/XP/Vista/7/8).
- 128 MB of RAM minimum (256 MB recommended).
- 30 MB of free hard drive space.
- Adobe Acrobat 6.0 or higher (required to display PDF files). The program may be downloaded free from www.adobe.com.
- Club Accounting version 3.2 (CA3) or higher.
- A current Club Accounting Maintenance contract.

Preparing Your Club Data

Before generating tax forms, make sure that your club accounting data is properly prepared. We recommend that you wait until you have all the necessary data and have performed a reconciliation of all accounts before completing your tax forms. Necessary data includes year-end brokerage and bank statements; records of all buys, sells, dividends, interest, and service charges through December 31, 2012; and

Form 1099s issued by your financial institutions. *It is likely that you will not have this information until mid-February*. Once you have all the necessary data and the club has conducted their annual audit, close out the books for the year:

- 1) Launch Club Accounting 3.
- 2) Select **Tools** > **Year-end Tasks**. Follow the instructions.

Installing the Club Tax Printer

There are two installation options:

Download the program installer from the Internet:


- Go to www.iclub.com/taxes/download/.
- Click on the appropriate tax printer program.
- The installation program launches automatically (if you select **Open**).
- If you choose not to allow automatic installation, or choose to **Save** the downloaded file to your computer, install the program manually by clicking on the **2012 Club Tax Printer Setup** icon in the location in which it was saved.
- You **do not** need to download the installer onto the computer on which Club Accounting 3 is installed. You may download it onto any computer and then transfer the installer to the CA3 computer via a thumb drive or other device, and then install the Tax Printer. *If you have trouble download the installer, try this approach.*

Install from a CD:

• Insert the CD into your computer's CD-ROM drive. The installation program should launch automatically.

Running the Club Tax Printer

The Club Accounting Tax Printer is not a separate program. It installs as an add-on to Club Accounting 3 (CA3). Select **Taxes** from the menu to run the tax module.



If you have multiple clubs licensed in your CA3 software, you will select the club from a list of presented when you start the program. If you would like to generate tax forms for several clubs, you will need to purchase a Tax Printer serial number for each club. See www.iclub.com/taxes/ for more information.

Registering the Tax Printer

When starting the tax printer for the first time, you will see the registration window. You must register your program over the Internet with your Tax Printer serial number before it is usable. Your Tax Printer serial number is proof that you purchased a

license to use this program. It is included with your Tax Printer packaging. If you purchased the downloadable version of this program, your Tax Printer serial number is provided via email and in your order receipt.

Draft and Final Forms


The Club Tax Printer software is often distributed before final forms have been released by the IRS and the states. When you initially install the program, it may display preliminary forms with a "DRAFT" watermark. **Draft forms may not be used to file a return with the IRS or your state.** They are provided so that you may get a head-start on the preparation of forms, diagnose any technical problems, and ensure that your tax printer and club accounting software are working properly.

The Club Tax Printer has an automatic updater built into the program. Each time you start the Club Tax Printer, it will check the Internet to see if any updates are available. Of course, you must be connected to the Internet in order for the auto-updater to work. When an update is available, the program will download and automatically install the new version. To check the release schedule for the IRS and state forms, please check www.iclub.com regularly through the tax season.

Auto-Updating the Program with Final Forms

When an update to your Club Tax Printer is available, you will be prompted to have the program automatically download and install the update. When final forms are released by the IRS, they are delivered to your computer via this auto-updater.

Note: Users of **Windows 7**, **Windows 8**, and **Windows Vista** may see a Windows User Access Control (UAC) message asking "Do you want to allow the following program from an unknown publisher to make changes to this computer?" Click **Yes**, and the following dialog box will appear:



Click **OK** to continue with the installation.

Entering Your Club Information

Once you have registered, over the next several screens you will be prompted to enter information about your club necessary to generate your club's tax forms.

1. Additional Information for REITs/Mutual Funds/"Other" Securities:

 If your club owned Real Estate Investment Trust (REIT), mutual fund, or security classified as "Other" in your Club Accounting 3 program, you will be

prompted to enter the amount of qualifying dividends and unrecaptured Section 1250 gains that have been reported on Form 1099 for those securities.

• If your club did not own any of those securities, you will not see this screen.

Club Information and Question 1:

- *Club Address:* Enter your club's legal address as registered with the IRS.
- Date business started: The date that your club formed as a partnership.
- Check the *Amended Return* box **only** if you are filing an amended return.
- 1. Type of partnership: Most clubs are formed as general partnerships.

Questions 2 - 3:

- 2. Did any individual or estate own, directly or indirectly, an interest of 50% or more in the profit, loss, or capital of the partnership?
 Mark appropriately. Most clubs will leave this unchecked. If your club is a family partnership, review the rules for constructive ownership before answering this question.
- 3. Did the partnership file Form 8893, Election of Partnership Level Tax Treatment, or an election statement under section 6231(a)(1)(B)(ii) for partnership-level tax treatment, that is in effect for this tax year?

 We recommend that you do not make this election. If your club had ten or fewer partners throughout the 2012 tax year, you may elect to answer Yes to this question and Form 8893 will be generated by the software (to be filed with your return). You should then enter your designated TMP information below. (If you previously filed Form 8893 with the IRS, check the box, enter your TMP information below but do not send the generated Form 8893 with your return.) See Form 1065 instructions for more detail.

If your club had more than ten partners at any time during the 2012 tax year (see guidelines above) then your club is already subject to Partnership Level Tax Treatment. Leave this box unchecked. You may still provide the name of your club's designated TMP below if desired.

- o Name of the Tax Matters Partner (TMP)
- o Identifying number of the TMP (usually a Social Security number).
- o In the upper box enter the street address.
- o In the lower box enter the city or town, state, and ZIP code.

Questions 4 - 8:

- 4. Is this partnership a publicly traded partnership as defined in section 469?
 Mark appropriately. Most clubs will leave this unchecked.
- 5. Does the partnership satisfy all four of the following conditions? Mark appropriately. Most clubs will check this box.
 - a. The partnership's total receipts for the tax year were less than \$250,000.
 - b. The partnership's total assets at the end of the tax year were less than \$1 million.
 - c. Schedules K-1 are filed with the return and furnished to the partners on or before the due date (including extensions) for the partnership return.

- d. The partnership is not filing and is not required to file Schedule M-3
- 6. During the tax year, did the partnership have any debt that was cancelled, was forgiven, or had the terms modified so as to reduce the principal amount of the debt? Mark appropriately. Most clubs will leave this unchecked.
- 7. At any time during the tax year, did the partnership distribute to any partner a tenancy-in-common or other undivided interest in partnership property? Mark appropriately. Most clubs will leave this unchecked.
- 8. If the partnership is required to file form 8858, *Information of Return of U.S. Persons with Respect to Foreign Disregarded Entities*, enter the number of Forms 8858. Mark appropriately. Most clubs will leave this blank.

Questions 9 - 12:

- 9. At any time during the calendar year 2012, did the partnership have an interest in or a signature or other authority over a financial account in a foreign country (such as a bank account, securities account or other financial account)? If "Yes" enter the name of the foreign country: Fill in appropriately. Most clubs will leave this blank.
- 10. Does the partnership have any foreign partners? If "Yes", enter the number of forms 8805, Foreign Partner's Information Statement of Section 1446 Withholding Tax, filed for this partnership.
- 11. Enter the number of Forms 8865, Return of U.S. Persons with Respect to Certain Foreign Partnerships, attached to this return.
- 12. IRS Center:
 Partnerships do not send their tax forms to the same place as individuals.
 Choose the appropriate IRS center for your club from the drop down list. If you do not know where to file, click on the convenient Where do I file? button. Please note that the address is simply a city and ZIP code. The post office knows where to route your taxes based on that alone.

Generating Your Tax Forms

You are nearly ready to print your Club Tax Returns. We recommend that you generate a complete return, and then extra copies of Schedule K-1's for each member. Check the appropriate boxes to print the Form 1065 and Schedule D. The scrollable window lists each member active during the Tax year. A Schedule K-1 prints for each club member highlighted in the list.

Reporting Security Cost Basis on Sales (New for 2012)

- If your club sold securities during the year, then the 1099-B Cost Basis window will appear at this point in the process. For each tax lot of each security sold during the year, you must enter the cost basis reported by your brokerage firm on Form 1099-B. Enter the amount reported even if it is different from the amount reported by your Club Accounting 3 records.
- If the basis is not provided by your brokerage, check the "Basis not reported on 1099" box. This may be the case for securities purchased prior to 2011.
- If no Form 1099 was received for the sale, check "No 1099 received for sale."

Click OK to continue.

Printing Your Tax Forms

Creating PDF files: Select **Finish** to generate forms in PDF format and launch the Adobe Acrobat Reader. From Adobe Acrobat Reader, you can save a copy of the files to your computer or print them directly.

Printing your tax forms: To print tax forms, click on the printer icon or go to the **File > Print** menu item after you have created a PDF of the tax return.

Saving your tax forms: To save your forms in PDF format, click on the disk icon or go to the **File > Save** menu item. The files will be saved in Adobe's PDF format. You may read these at any time using the Acrobat Reader.

Additional notes: A Tax ID number for each member is required for the club's tax returns to be complete. If the message *No Tax ID Entered* shows up next to a member's name, that member's Social Security Number was not entered in Club Accounting. Fill it in by hand after you have printed the appropriate tax form.

The 1065/K-1 software prints the following forms and schedules:

- Form 1065: U.S. Partnership Return of Income, pages 1-4.
- Schedule D (Form 1065): If your club has no capital gains or losses for the year, this schedule is unnecessary and will not be printed. There also may be supplemental pages printed.
- Supporting schedules for Schedule K: Partners' Shares of Income, Credits, Deductions, etc. There also may be supplemental pages printed.
- Schedule K-1 and K-1 Instructions: For each partner.
- Form 8893: Only if chosen as per Step 2, question 4.

Not all pages of Form 1065 and associated schedules will contain data. In most cases, the first page of Form 1065 contains no data except identification, date information, and the number of attached Schedule K-1s.

Note: If required, Schedules L, M1, and M2 must be completed manually. Please see Common Problems & Release Notes below.

What You Need to Send to the IRS

2012 Club Tax Printer software prints IRS acceptable schedules required for filing the return. Investment clubs should file one copy each of:

- 1) Form 1065 (plus Schedule D and any supplementary schedules as necessary. If your club has no gains or losses on the year, the tax software will not print Schedule D. If this is the case, you do not need to file Schedule D.)
- 2) A Schedule K-1 for each member.

Make sure to send it with confirmation, Registered Mail or Return Receipt Requested.

What You Need to Give to Your Members

Club members (including members who withdrew from the club during the year) must be given a copy of their respective Schedule K-1s for use in preparing their personal tax returns. This copy is to be kept with their tax records and is not filed with the IRS. You must also give each member of your club one copy of the K-1 instructions, found on page 2 after you generate your complete forms. **Any mem-**

bers who withdrew during the year must also be provided with a K-1 along with a copy of the Withdrawal Report for their final distribution.

What You Need to Keep for Club Records

The club should keep a copy of Form 1065, Schedule D (if prepared), each Schedule K-1, and any supporting statements and attachments as part of its permanent records. We recommend keeping electronic PDF files in addition to paper copies.

Common Problems and Release Notes

- The Club Tax Printer requires registration before the program can be run. Registration is done over the Internet from within the registration screen.
- If the program takes a long time to load your Adobe Acrobat Reader and Tax Forms, your computer may lack sufficient memory or free hard drive space. Select fewer forms to print faster, then repeat for remaining forms.
- The Club Tax Printer, in accordance with IRS rules, does not print zeros (0) on form spaces where the value is zero. Those fields are left blank.
- Many fields on the tax forms will be blank and are intended to be blank.
 The same forms your club uses are used by partnerships that own property and have payrolls, neither of which applies to your investment club. Related fields are therefore blank.
- Pertinent IRS forms, publications, and instructions are on the CD and in the program folder after installation.
- If your club had assets with a cost basis of \$1,000,000 or more, or had income of \$250,000 or more, some schedules must be completed manually. Clubs having either of these conditions should seek tax advice from a certified tax preparer.
- The Club Tax Printer does not support the IRS 754 Election.
- The Club Tax Printer software uses industry standard Adobe Acrobat software to generate your tax forms. A free copy of Acrobat Reader installs with the tax program, or can be downloaded from www.adobe.com.
- The Club Tax Printer will correctly allocate qualifying and non-qualifying dividends ONLY if all of the following conditions are met:
 - o All dividends linked to securities are entered properly in the books.
 - o Ex-dividend dates are entered for all common stock dividends.
 - REITs, mutual funds, and "other" (Limited and Publicly Traded Partnerships, etc.) securities are correctly identified.
