#### Important: Partnership Return Deadlines

The deadline for filing Federal IRS partnership tax returns and providing partners with Schedule K-1s is March 15th. Many states have adjusted their partnership filing deadlines, so check with your state to ensure that you meet their filing date. If allowed, partnerships may apply for an extension using the state's appropriate form. Members of your club should not file their personal returns until they have received the appropriate information from the club.

#### Using the Club State Tax Printer

This **Club State Tax Printer** program works by reading your Club Accounting data, performing calculations, and generating your tax forms. The program does not alter data stored in the Club Accounting software. To properly use this program, your accounting records must be up-to-date. We recommend running the year-end wizard and the **Club Federal Tax Printer** before preparing your state tax return.

#### System Requirements

Use of the Club State Tax Printer software requires:

#### For Club Accounting 3 (CA3)

- Compatible Windows operating system (Windows 7/8/10).
- 256 MB of RAM minimum.
- 30 MB of free hard drive space.
- Adobe Acrobat 6.0 or higher, available free from <u>www.adobe.com</u>.
- Club Accounting version 3.2 or higher.
- Current Accounting Maintenance contract.

#### For myICLUB.com

- Current generation web browser (Internet Explorer, Microsoft Edge, Google Chrome, Mozilla Firefox, Apple Safari).
- Internet access.
- Adobe Acrobat 6.0 or higher, available free from <u>www.adobe.com</u>.
- Current myICLUB.com subscription

#### Installing the Club State Tax Printer

There are different options for installing the Club Tax Printer, depending on whether you use **Club Accounting 3** or **myICLUB.com**:

1. If you have purchased the downloadable version of the Club Tax Printer for

**Club Accounting 3** (CA3), download it from <u>www.iclub.com/taxes/download/</u>. Save the installer to your computer desktop. Once the download is complete, double-click on the **Club State Tax Printer Setup** icon and follow the prompts. Once the installation is complete, close and re-open CA3.



You do not need to download the installer onto the same computer on which you run Club Accounting 3, but can download it onto *any* computer. Use a thumb or flash drive to transfer the installer to the CA3 computer, and install the Tax Printer. Try this approach if you have a slow Internet connection or have trouble downloading the installer.

2. If you purchased the **Club State Tax Printer for myICLUB.com**, there is no installation needed. Visit the **Taxes** tab of **myICLUB.com** and click the button to run the program.

#### Running and Registering the Club State Tax Printer

The Club State Tax Printer for Club Accounting 3 is not a separate program, but an add-on to the program.

Select **Taxes** from the CA3 menu to run the tax module.

When starting the **Club State Tax Printer for CA3** for the first time, you will see the registration window. You must register your program over the Internet with your Tax Printer serial number before it is usable. Your serial number is proof that you purchased a license to use this program and is included with the Tax Printer order receipt sent to you via email.

If you have multiple clubs licensed in your CA3 software, you will select the club from a list presented when you start the program. If you would like to generate tax forms for several clubs, you will need to purchase a Tax Printer serial number for each club from <u>www.iclub.com/taxes/</u>.

No registration is required for the **Club State Tax Printer for myICLUB.com**. Visit the **Taxes** tab of **myICLUB.com** and click the button to generate, print, and download your tax returns.

#### Special Note for Clubs in CA, MA, NY, NJ, and WI

**Partnerships in California** may now file their state returns electronically using the **Club State Tax Printer for myICLUB.com**, and paper forms are no longer provided in the **Club State Tax Printer**. Clubs in California using Club Accounting 3 should contact our Support team for assistance in converting their data for use in **myICLUB.com**.

**Investment partnerships in Massachusetts** that meet **any one** of the following criteria must by law file electronically (E-FILE) and cannot use the ICLUBcentral Club State Tax Printer to submit a paper return (however, you may use the program to generate the input for the return and associated schedules).

- Have 25 or more partners (as determined by number of Schedule K-1s at the federal level or Schedule 3K-1s at the state level)
- Have more than \$50,000 in gross income (interest, dividend, and other income).
- Have more than \$100,000 in stock sale proceeds (gross sales proceeds, not taxable capital gain).

New Jersey investment clubs with 10 or more members (as determined by the number of Schedule K-1 forms at the Federal level) must file their NJ-1065 over the Internet at

the NJ state tax website. There are a significant number of calculations required to generate the input for the NJ-1065 return and associated schedules. The NJ Club State Tax Printer will make these calculations for you and prepare a full return which you can then transcribe to the web based forms.

**Partnerships in Wisconsin** are required to e-File their returns, and thus paper forms are no longer provided in the **Club State Tax Printer**. The **Club State Tax Printer for myICLUB.com** supports e-Filing for Wisconsin as of the 2019 tax year, and will not generate paper forms for filing. Clubs in Wisconsin using Club Accounting 3 should contact our Support team for assistance in converting their data for use in **myICLUB.com**.

**Partnerships in New York** are required to e-File their returns, and thus paper forms are no longer provided in the **Club State Tax Printer**. Clubs using **myICLUB.com** may e-File their return using the **Club State Tax Printer for myICLUB.com**. Clubs in New York using Club Accounting 3 should contact our Support team for assistance in converting their data for use in **myICLUB.com**.

#### Preparing the Club Data

Note: Skip this step if you have finalized your returns using the Club Federal Tax Printer.

Before generating tax forms, make sure that your accounting data is properly prepared. We recommend that you wait until you have all necessary data and have performed a reconciliation of all partnership accounts before completing your taxes. Necessary data includes your year-end brokerage and bank statements; all buys, sells, dividends, interest, and service charges through December 31; and Form 1099s issued by your financial institutions. *It is likely that you will not have this information until mid-February.* 



We recommend that you view the "Closing the Books at Year-End" webinar video available in the <u>Learning section of ICLUB.com</u> for complete year-end procedures.

Once you have all the necessary data and the club has conducted its annual audit, close out the books for the year, including creating a year-end Valuation Statement and Allocating Income and Expenses for the year.

Users of **Club Accounting 3** may close the books by following the instructions in the year-end task wizard available under **Tools** > **Year-end Tasks**.

#### About Draft and Final Forms

The Club State Tax Printer software is often distributed before final forms have been released by states. When you initially install the program, it may display preliminary forms with a "DRAFT" watermark. **Draft forms may not be used to file a return with your state.** They are provided so that you may get a head-start on the preparation of forms, diagnose any technical problems, and ensure that your tax printer and club accounting software are working properly.

The **Club State Tax Printer for myICLUB.com** is updated automatically whenever a new version is available. Whenever you run the program from the **Taxes** tab, it is the most current release.

The **Club State Tax Printer for CA3** has an automatic updater built into the program. Each time you start the Club Tax Printer, it will check the Internet to see if any updates are available. Of course, you must be connected to the Internet in order for the auto-updater to work. When an update is available, the program will download and automatically install the new version. To check the release schedule for state forms, please check the home of page of <u>www.iclub.com</u> regularly through the tax season.

#### Auto-Updating the Program with Final Forms

When an update to the **Club State Tax Printer for CA3** is available, the program will prompt you to automatically download and install it. When final forms are released, they are delivered to your computer via an auto-updater.

If updates are available, you will be alerted to how many are available and their size. Click **Yes** or **OK** to agree, and a dialog box will appear. Click **OK** to continue.

When installing updates, you may find the progress bar does not fill all the way before the updater gives the option to click **OK**. If that happens, don't worry; as long as the **OK** button is clickable on the updater, your copy has installed the update.

The **Club State Tax Printer for myICLUB.com** is updated automatically with final forms behind the scenes, with no action required by users.

#### **Entering Your Club Information**

Once you have registered, you will see a screen listing the states which are included in the **Club State Tax Printer**. Choose your state and click **OK**. On the following screens, you will be prompted to enter information about your club needed to generate your club's tax forms. The specific questions and input required vary by state.



We recommend that you view the "Preparing Club Taxes" webinar video available in the <u>Learning section of ICLUB.com</u> for complete details on the tax preparation process.

Please refer to the help files within the program for information that is relevant to your specific state's tax return forms. If necessary, you may use the **Club State Tax Printer** to complete the forms for more than one state for a single club. States that require a return if any member is a resident (regardless of where the partnership is domiciled) include Georgia, Missouri, New Jersey, New York, Pennsylvania, Oregon, and West Virginia. Tax laws change frequently, so confirm the regulations with any states in which your partners reside.

#### **Generating Your Tax Forms**

You are now ready to print your state tax return. You should generate a complete return, and then, if your state requires a schedule similar to the Federal Schedule K-1, copies of this schedule for each member. Members of clubs using **myICLUB.com** can click the links in the **Taxes** tab to download and/or print their returns.

Check the appropriate boxes to print the main tax return and any additional schedules (as appropriate for your state).

**Create PDF Files.** Selecting **Finish** will generate forms in PDF format and launch Adobe Acrobat. From Adobe Acrobat, you can save or print your forms.

**Print Your Tax Forms.** To print forms, click on the printer icon or select the **File > Print** menu item after you have generated your club's tax return.

**Save Your Tax Forms.** To save tax forms to your computer, click on the disk icon or go to the **File > Save** menu item. The files will be saved in Adobe's PDF format. You may read these at any time using the Adobe Reader.

Additional Notes. A "Partner's identifying number" for each member is required for the tax return to be complete. If the message "No Tax ID Entered" shows up next to a member's name, or that box is empty, that member's Social Security Number was not entered in the Club Accounting program. You can edit each member's profile to add the number and then regenerate the forms, or you can add the numbers by hand to the paper forms. If you choose to write in the numbers on the printed forms, note that the saved PDF forms will not include Social Security Numbers, so saving a hard copy with the numbers is preferred.

Select Quit to exit the Tax Printer.

What to Send to Your State Tax Agency. The Club State Tax Printer software prints returns and schedules required for filing your club's tax return in a format acceptable to your state's Tax Department. Instructions for what to send and where to send your return can be found on the cover sheet printed with the return.

What to Give to Your Members. If your state requires, give each member a copy of his/her state equivalent to Federal Schedule K-1. This schedule will be used in filing their personal state tax returns. *Individuals who withdrew from the club during the year must also be provided with the appropriate tax forms as well as their final Withdrawal Report.* 

What to Keep for Club Records. The club should keep a copy of the full state return, all attached schedules, and any supporting statements and attachments as part of its permanent records. We recommend keeping electronic PDF files in addition to paper copies.

#### **Common Problems and Release Notes**

- The Club State Tax Printer for CA3 requires registration before the program can be run. Registration is done over the Internet from the registration screen.
- If you find the program taking a long time to load and/or print your Adobe Acrobat Reader and tax forms, your computer or printer may lack sufficient memory. Select fewer forms to print, then repeat the process.
- Links to forms and instructions are found in the program's help section.
- If your return contains a watermark reading "DRAFT," final forms are not yet available. DRAFT forms may not be submitted to your state.
- The **2019** Club State Tax Printer software uses Adobe Acrobat to generate your tax forms. A free copy of Adobe Reader installs with the tax program, or can be downloaded from <u>www.adobe.com</u>.
